- b) Upon request after the event, I can export to facebook so you can use on your pages, send in email, etc. *(a logo will appear in the lower right corner)*
- c) Get online and order professional prints at standard web prices.

### **Tier 3 - \$20.00 Full Non-Exclusive Rights (most popular)**

- a) Get online and download any or all *(full res, no logo)* .jpg original images from this event. Have these images printed yourself, send in email, print at home, burn to CD, etc.
- b) Get online and order professional prints at little above my cost *(major discount for professional printing; much better quality than local retail stores)*
- c) Have your photo selections burned to a CD and mailed to you **(\$2.00 extra)**
